

## WAIVER, RELEASE & INDEMNITY AGREEMENT

I promise and warrant that I will not file, cause to be filed, tolerate, or permit to remain filed by any person or entity any lawsuit or other claim based upon any injury, illness, loss, or damage I am releasing herein. In the event that such a lawsuit is filed by me or on my behalf, I will indemnify TBGTE Golf League Inc. and any related person or entity named in such lawsuit or other claim for any expenses or losses, including attorneys' fees, it incurs as a result.

I further promise and warrant that if anyone should file a lawsuit or other claim against TBGTE Golf League Inc. and/or any related person or entity relating to any injury, illness, loss, or damage caused by or otherwise based upon my conduct, I will indemnify TBGTE Golf League Inc. and any related person or entity named in such lawsuit or other claim for any expenses or losses, including attorneys' fees, it incurs as a result.
